Event Participation Consent Form

Consent for Use of Personal Information, Photos, and Videos

Introduction

Thank you for attending our event. As part of the event, we request your consent to capture and use your personal information, including photos and videos, for promotional purposes. This will help us showcase the success of the event, inspire future participants, and promote similar initiatives.

1. Purpose of Consent

Once your withdrawal request is received, the Organizer will ensure that your personal information, photos, and videos are no longer used in any new promotional materials within **90 days** of receiving the request.

Please note that while we will cease using your information in new promotional activities, any content that has already been published, distributed, or shared prior to your withdrawal request may continue to be used in those materials.

8. No Financial Compensation

By signing this form, you acknowledge that no financial compensation will be provided for the use of your personal information, photos, or videos in promotional activities. This consent is given voluntarily and without expectation of payment or other compensation.

9. Data Protection and Privacy

unauthorized third parties. You have the right to access, rectify, or request the deletion of your personal information at any time.

In the event of any dispute or disagreement arising out of or in connection with this consent form, the parties agree to first attempt to resolve the dispute through informal negotiations. 11. Governing Law and Jurisdiction

This consent form shall be governed by and construed in accordance with the laws of **Kenya**, and any disputes relating to this agreement will be subject to the exclusive jurisdiction of the courts of **Kenya**.

12. Notice

Any notices or other communications required or permitted to be given under this consent form shall be in writing and delivered by email to the addresses specified below. Notice will be deemed received when the sender receives confirmation of delivery on email.

13. Entire Agreement

This consent form constitutes the entire agreement between the parties with respect to its subject matter and supersedes all prior or contemporaneous agreements, communications, and understandings, whether written or oral, between the parties.

14. Amendments

This consent form may not be amended or modified except in writing, signed by both parties.

15. Severability

If any provision of this consent form is found to be invalid or unenforceable by a court of competent jurisdiction, such provision shall be severed from the remainder of the agreement, which shall remain in full force and effect.
